## HOW TO USE THIS TOOLKIT

Here's how you can use it to find the help and information you need...

1. Turn to the Table of Contents and you will find a list of sections. One section after the Introduction is called Hotlines. These are phone numbers that put you in contact with the various programs and services that may be able to help you. (Many of these hotlines and emergency phone numbers are repeated in the various sections.)
2. One important and easy-to-remember number is 211, a toll-free referral hotline which helps people who need health and social services.
3. 211 is open 24 hours a day, 7 days a week. When you call, you will talk with a trained operator who can help you find the services you need that are nearest to you. If you're not sure which number to call, start by calling 211!
4. Use the Table of Contents to find the section with the services or programs you need or want to find out about.
5. Towards the back of the Toolkit you will find additional resources and forms. This contains information you will find helpful, such as lists of **County Public Health Centers, County Family Resource Centers and Alcohol and Drug Services Locations.**

## TRANSITION TIPS

Reentry can be both exciting and frustrating! Your attitude towards your release from prison should be a simple matter of getting resettled, resuming routines, and reestablishing your relationships; but reality proves there is much more to it than that.

Here is a list of tips to consider that can help you go through the transition process:

1. Mentally prepare for the adjustment process. Be prepared for anything!
2. Give yourself permission to ease into the transition. Allow yourself time to acclimate to the new environment.
3. Give yourself time. You'll need time to relax and reflect upon what is going on around you, how you are reacting to it, and what you might like to change.
4. Understand that the familiar will seem different. You have changed; home has changed. You will see familiar people, places, and behaviors from new perspectives.
5. Expect to do some 'cultural catching up'. Clothes, trends, language, and more have changed, too!
6. Reserve judgments. Reserve all judgments of others, but especially negative judgments; just as you would like to have others reserve judgments of you. Resist the impulse to make snap decisions.
7. Expect mood swings. It is entirely possible for you to feel ecstatic one moment and completely defeated a short time later. It's okay; it is a part of the process.
8. Allow sufficient time for reflection and self-analysis. Your most valid and valuable analysis of an event is likely to take place after allowing time for reflection.
9. Respond to inquiries thoughtfully and carefully. Prepare to greet surprise questions with a calm, thoughtful approach. If you find yourself being overly defensive or aggressive, take a deep breath and relax.
10. Seek support networks. Don't isolate yourself!

**To prepare yourself for upcoming challenges, it is safe to expect the following:**

- You will have to prove yourself (over and over and over).
- People will make many assumptions about who you are now.
- You will be different than when you left; your family and friends will be different, too!
- People will expect things from you, especially a plan for your life.
- The way you'd hoped things would be will be different from the way they are.
- You will feel 'down' or depressed after the initial return 'honeymoon' period.

## **TOP 11 THINGS YOU CAN DO FOR A SUCCESSFUL REENTRY INTO THE COMMUNITY**

1. Find safe and stable housing.
2. Find stable source of food.
3. Figure out and get transportation.
4. Get important documents: birth certificate, social security card, California ID card (or driver's license).
5. Call 2-1-1 to see if you qualify for medical coverage and food stamp assistance.
6. Go to a career center for resume and job resources.
7. Clear up child support and legal issues.
8. Take care of medical needs including: prescription refill, dental, vision (eye glasses), physical examination, and HIV/STD/Hepatitis testing and treatment.
9. Attend community support meetings (AA, NA and/or local faith based organizations).
10. Build a positive support system of friends, families, and other helpful people. Get social support through a program for reentrants.
11. Attending the Division of Adult Parole Operations (DAPO) or PACT Meeting.

## SUBSTANCE ABUSE

### **What Is This?**

Alcohol and Drug (or substance abuse) services provide treatment that is intended to help addicted individuals stop compulsive drug seeking and use. Treatment can occur in a variety of settings, in many different forms, and for different lengths of time. Because drug addiction is typically a chronic disorder characterized by occasional relapses, short term, one-time treatment is usually not sufficient. Treatment can be a long-term process that involves multiple interventions and regular monitoring.

### **Do I Qualify For These Services?**

Each individual Alcohol and Drug service provider has different requirements. Contact the specific provider to find out what documents you need to bring, the cost, and eligibility requirements.

### **How Much Will It Cost?**

The cost for treatment depends on the type of treatment you need. The best way to find out the range of costs for treatment is to call the treatment program for details. Also, remember that the cost of drug addiction and alcoholism, if not treated, can far exceed the cost of treatment.

If you need treatment for a substance abuse problem, call our main number, 707 784-2220, during the normal business hours of 8:30 AM to 5:00 PM Monday through Friday to connect with services. You will be asked some questions and instructed on what to do next.

If you are currently under the influence and wish to go to a detox facility, call the SSAC detox in Vallejo at 419 Pennsylvania St. The phone number is 643-2715. The detox is open 24 hours per day, seven days a week.

If you are in an emergency, dial 911.

This division provides a range of prevention, intervention, treatment, and recovery services for alcoholism and other drug addictions. Through community and county-based programs, we serve approximately 4,000 persons per year. Services include but are not limited to alcohol and drug detoxification, outpatient counseling, and residential treatment.

## SUBSTANCE ABUSE – OUTPATIENT TREATMENT AGENCY



**Healthy Partnerships (HP)** is an out patient AOD behavioral healthcare provider and State Licensed Driving Under the Influence (DUI) Program committed to serving clients with effective behavioral healthcare treatment services delivered in an atmosphere of compassion and respect. HP has adapted a cognitive behavioral treatment approach coupled it with a comprehensive educational curriculum to forge a powerful treatment model. In order to meet the needs of Solano County residents and the surrounding areas in 1997 HP opened the first office in Vacaville and has established two (2) additional offices located in Dixon and Fairfield and in April 2005 extended services to Rio Vista. HP is certified by the California Dept. of Alcohol and Drug Programs for Out Patient and Drug MediCal treatment services.

**Healthy Partnerships (HP)** provides Reentry / Reintegration services through Healthy Hope Reentry Solutions (HHRS). Persons with a criminal background who desire assistance and face barriers to successful reintegration can contact anyone of our offices for assistance. HHRS System of Care and Case Management places special focus on Solano County Jail and the process of identification needs and services.

Our staff is a mix of helping professionals with one goal in mind: help those that come to our program to achieve recovery from addictive disease and increase their general health and well-being. HP employs substance abuse counselors who meet current state certification requirements, licensed professionals such as psychiatrist, physician, and interns from master's level programs and approved AOD certification institutions. Clinical Supervision is provided weekly for all counseling staff as a group or on an individual bases as needed. **Spanish speaking services are provided.**

## **DRIVING UNDER THE INFLUENCE - DUI**

### **1) I've just been arrested for DUI. What happens now?**

The officer is required by law to immediately forward a copy of the completed notice of suspension or revocation form and any driver license taken into possession, with a sworn report to the DMV. The DMV automatically conducts an administrative review that includes an examination of the officer's report, the suspension or revocation order, and any test results. If the suspension or revocation is upheld during the administrative review, you may request a hearing to contest the suspension or revocation.

You have the right to request a hearing from the DMV within 10 days of receipt of the suspension or revocation order. If the review shows there is no basis for the suspension or revocation, the action will be set aside. You will be notified by the DMV in writing only if the suspension or revocation is set aside following the administrative review.

### **2) At the time of my arrest, the officer confiscated my driver license. How do I get it back?**

Your driver license will be returned to you at the end of the suspension or revocation, provided you pay a \$125 reissue fee to the DMV and you file proof of financial responsibility. The reissue fee remains at \$100 if you were under age 21 and were suspended under the Zero Tolerance Law pursuant to Vehicle Code §§23136, 13353.1, 13388, 13392. If it is determined that there is not a basis for the suspension or revocation, your driver license will be issued or returned to you.

### **3) The officer issued me an Order of Suspension and Temporary License. What am I supposed to do with this document?**

You may drive for 30 days from the date the order of suspension or revocation was issued, provided you have been issued a California driver license and your driver license is not expired, or your driving privilege is not suspended or revoked for some other reason.

- 4) The Notice of Suspension that the officer gave me at the time of my arrest states I have ten days to request an administrative hearing. What is the purpose of this hearing and what can it do for me?**

A hearing is your opportunity to show that the suspension or revocation is not justified.

- 5) For how long will my driving privilege be suspended if I took the chemical test?**

If you are 21 years of age or older, took a blood or breathe test, or (if applicable) a urine test and the results showed 0.08% BAC or more:

- A first offense will result in a 4-month suspension.
- A second or subsequent offense within 10 years will result in a 1-year suspension.

If you are under 21 year of age, took a preliminary alcohol screening (PAS) test or other chemical test and results showed 0.01% BAC or more, your driving privilege will be suspended for 1 year.

- 6) Do I need a hearing to get a restricted license to go to and from work?**

No. A request for a restricted license cannot be considered at the DMV hearing. You may apply for a restricted license to drive to and from work at any DMV field office.

- 7) The officer stated I refused to take a chemical test. What does this mean?**

You are required by law to submit to a chemical test to determine the alcohol and/or drug content of your blood. You did not submit to or complete a blood or breath test after being requested to do so by a peace officer. As of January 1999, a urine test is no longer available unless:

- The officer suspects you were driving under the influence of drugs or a combination of drugs and alcohol, **or**
- Both the blood or breath tests are not available, **or**

- You are a hemophiliac, or
- You are taking anticoagulant medication in conjunction with a heart condition.

**8) How long will my driving privilege be suspended for not taking the chemical test?**

If you were 21 years or older at the time of arrest and you refused or failed to complete a blood or breath test, or (if applicable) a urine test:

- A first offense will result in a 1-year suspension.
- A second offense within 10 years will result in a 2-year revocation.
- A third or subsequent offense within 10 years will result in a 3-year revocation.

If you were under 21 years of age at the time of being detained or arrested and you refused or failed to complete a PAS test or other chemical test:

- A first offense will result in a 1-year suspension.
- A second offense within 10 years will result in a 2-year revocation.
- A third or subsequent offense within 10 years will result in a 3-year revocation.

**9) How is the DMV suspension or revocation for the DUI arrest different from the suspension or revocation following my conviction in criminal court?**

The DMV suspension or revocation is an immediate administrative action taken against your driving privilege only. This is called Administrative Per Se (APS). Any sanctions imposed by DMV under APS are independent of any court-imposed jail sentence, fine, or other criminal penalty imposed when a person is convicted for driving under the influence (DUI).

The suspension or revocation following a conviction in court is a mandatory action for which jail, fine, or other criminal penalty can be imposed.

Sober living environments are primarily meant to provide housing for people who have just come out of recovery centers and need a place to live that is structured and supporting for those in recovery. However, it is not required to have come from a recovery center.

Many people, with long histories of addiction, with mental disorders, or without stable or sober housing and family support, are greatly at risk as they transition out of treatment and back into an environment that can lead to relapse. For these people, sober living housing (halfway housing) can be a great alternative.

### **Do I Qualify To Get It?**

Each individual sober living home will have different requirements for the residents, but many will have these typical requirements:

1. No drugs or alcohol.
2. Mandatory AA meeting attendance.
3. Random drug tests.
4. On-time bill payments.
5. General acceptance by peer group at the sober living house.
6. Must be able to take care of themselves fully on a daily basis.
7. Must be active in their own personally-developed recovery program.

## RESIDENTIAL TREATMENT

Residential Treatment refers to the extended stay facilities with intensive services, often focused at a specific population.

These are less intensive than an inpatient facility such as hospitals as the treatment is longer term. Patients stay at residential facilities that usually have rules and regulations that facilitate the safety of patients and promote their movement towards independence.

Residential treatment stays can range from a few weeks to several months. Insurance coverage for this level of care varies.

A residential treatment center provides individualized care to people who stay in them. It is often a last resort option when all other attempts at solving your problems have failed. Residents of treatment centers can stay for as little as one month to as long as four years or more. There are many factors to take into consideration when deciding whether to enroll yourself or a loved one in a residential treatment center.

### Types

Residential treatment centers are generally designed to meet the specific needs of a well-defined group of people. For example, there are residential treatment centers that assist people who suffer from drug and alcohol addictions and eating disorders. Residential treatment centers also exist to help children who have severe problems.

### Function

For drug and alcohol addicts and eating disorder sufferers, residential treatment centers are often called "inpatient treatment." They provide recovering addicts and eating disorder sufferers the necessary support and structure to enable long-term recovery. Residential treatment centers for children house, treat and educate youths who have problems severe enough to require a strictly supervised environment. These centers take a multifaceted approach to address many problems that reach beyond the classroom and affect a child's daily life with peers, family and the rest of the world.

### Features

Residential treatment centers create an individualized and consistent plan to address your problems. They offer doctorate-level clinical staff and psychiatric intervention. Treatment centers provide medical support and

healthy diet and exercise regimens suited to your specific needs. Residential treatment centers for children provide support in three different areas: the classroom, living environment and clinical treatment.

#### Considerations

When you look into residential treatment centers, it is important to consider quality of care during treatment and follow-up. Make sure staff members are appropriately licensed and have good credentials. For addiction treatment centers in particular, national accreditation agencies evaluate the programs, so check whether the treatment center you're interested in has been rated. Also check what types of aftercare programs are available.

#### Warning

If someone you care about is in a residential treatment center, it is important to keep in mind that you cannot force him to heal. Painful feelings often arise for residents in treatment centers. Make sure your loved one receives ongoing support from multiple sources during and after the treatment center stay. Child residential treatment centers should be considered a last resort to help children with severe problems. Send your child to a center only if you have already tried or ruled out less intense intervention methods.

## TRANSITIONAL AND TEMPORARY HOUSING

Transitional housing programs provide housing arrangements for homeless families or individuals, which are stable and for a period spanning up to two years. The Urban Institute works in partnership with the U.S. Department of Housing and Urban Development to report on the characteristics and outcomes of transitional housing programs across the nation and gauge program success.

Community-based transitional housing programs were created as a way to keep an intermediate level of supervision over recently released prisoners and people discharged from mental health care institutions. Transitional housing helps these individuals develop skills and prepare for sustainable independent living. Transitional housing offers deeper-reaching services that emergency shelters do not sufficiently offer to address or reverse causes of homelessness.

## EMPLOYMENT

### Why Is It Important To Find A Job?

A job can help you in several ways. Of course, you need money to pay for a place to live, food, and other bills. But there are other reasons to get a job:

1. You start establishing a job history. Which shows you are responsible and are contributing to the community.
2. It shows you can handle the responsibilities of a job, which makes you a better prospect for other jobs if or when you decide to look for them.
3. It makes you feel better about yourself. You are getting up and going in to work every day; providing for yourself and your family.
4. Working at a job helps teach you how to get along with other people.
5. Having a schedule and responsibilities keeps you busy. It may help you avoid the people and situations that contributed to the behaviors that got you in trouble before.
6. You're making important changes in your life. It shows that you're taking charge of your life and that you are making good choices.

### What Are Some Other Important Tips For Finding A Job?

1. Be realistic. Know what skills, training and education that you have. You need to find something that fits you and your skill level; if you apply for jobs that you don't have the right skills for you can quickly become discouraged.
2. Take advantage of education or job training programs that may be available to you. Government agencies and non-profit organizations provide opportunities for you to get more training or education.
3. Eliminate jobs that your record will automatically disqualify you for. Your record may automatically disqualify you for some positions, especially government jobs requiring security clearances, military jobs, positions with insurance companies, banks or jobs working with children.
4. Research a job thoroughly. You may not qualify for it, but you don't know for sure without checking it out.
5. Start small and work your way up. Build your resume and get good professional references. Work hard in every position; and you can build experience and references that will make your criminal record less important to future employers.

6. Be honest about your history. It can be tempting to lie when an application asks if you've been arrested or convicted of a crime. Avoid the temptation: not only is this dishonest, chances are the lie will be discovered. If that happens, you'll almost always be turned down.
7. Know what to answer on applications. Some states and counties now prohibit employers from asking about certain offenses, offenses that are over a certain number of years old, or arrests that did not result in a conviction.
8. Explain your answer if asked about convictions or arrests. Job applications and interviewers will give you an opportunity to explain the circumstances behind the offense or alleged offense. Take this opportunity if it's offered—it could make the difference between getting the job or being rejected.
9. Employ yourself. If you're willing to work extra hard and you have marketable skills or abilities you may be able to make your own opportunities. You could start a yard maintenance business or provide contract computer services to companies, for example.
10. Consider joining the military. The military is selective, but depending on the type and number of offenses and the length of time since an offense, you may be able to get a waiver that will allow you to enlist. Consider the risks and benefits of military service.
11. Follow these steps when applying for a job: Complete the application, ask questions in the interview, and send thank you letters. You can make a good impression and increase your chances of getting the job.

## FOOD STAMPS

The Food Stamp Program helps single people and families with little or no income to buy food. Solano County issues food stamp benefits to approximately 20,000 needy residents each month.

### **Common questions asked about the Food Stamp Program:**

**Question:**

Can I get Food Stamps just for myself, if I live with my family or with others?

**Answer:**

People who live together and buy food and prepare meals together are grouped as a "household". Husbands and wives and most children under age 22 must be one household.

**Question:**

How long will I have to wait before I can get Food Stamps?

**Answer:**

If eligible for expedited services 3 calendar days. Otherwise no more than 30 days.

**Question:**

Can legal non-citizens get Food Stamps?

**Answer:**

Yes, most legal non-citizens are eligible for either the Federal Food Stamp Program or the California Food Assistance Program.

**Getting Food Stamps will not hurt you if you want to become a citizen.**

**Question:**

Can I get Food Stamps if I own a car?

**Answer:**

The rule on owning cars has recently changed. More people can own reliable transportation and still get Food Stamps.

**Question:**

How many assets can we have?

**Answer:**

Households with a member age 60 or older may have up to \$3000 in countable assets. Other households may have up to \$2000.

We don't count your home or the assets of people who get SSI.

**Question:**

What will I need to provide to get Food Stamps?

**Answer:**

- Proof you live in Solano County - rent receipt or copy of PGE bill
- Proof of Identity - driver's license, birth certificate or DMV ID
- Resident Alien Card (green card) if not a US citizen
- Income verification, pay stubs or UIB (Unemployment Insurance Benefit) stubs
- Social Security number or application for a number from the Social Security Administration.
